- Box 1** **Account Number** – Your VITA program account number.
- Box 2** **Organization** – Enter or update the name of your organization (ex: AARP).
- Box 3** **Additional Organization Information** – Enter or update the name of your department within your organization (ex: Human Resources).
- Box 4** **Contact Name (*Required*)** – Enter or update the first and last name of the contact person.
- Box 5** **Shipping Address (*Required*)** – Enter or update your complete street address or PO Box (ex: PO Box 123, 1234 Main St Ste 5).
- Box 6** **Additional Delivery Information** – Enter or update your additional delivery information (ex: 1st Fl, Commerce Bldg).
- Box 7** **City (*Required*)** – Enter or update your city.
- Box 8** **State (*Required*)** – Enter or update your 2-letter state identifier.
- Box 9** **Zip Code (*Required*)** – Enter or update your zip code.
- Box 10** **Telephone Number** – Enter your 10-digit U.S. telephone number (ex: (555)111-1111).
- Box 11** **E-mail Address (*Required*)** – Enter and verify your e-mail address.
- Box 12** **Country Code (*Required*)** – Select your country’s 2-letter identifier.
- Box 13** **Date Needed (*Required*)** – Enter the date needed (mm/dd/yyyy)
- Box 14** **Last Date Order Can Be Accepted (*Required*)** – Give the last date (mm/dd/yyyy) order can be accepted

After you have completed entering your quantities:

1. Select the “Save/Order” button located at the top right corner of this form to save it on your computer
2. Open your e-mail account using your e-mail service provider (ex: Yahoo, MSN, Microsoft Outlook)
3. Open and create a new e-mail
 - a. On the *To:* line, type pdf.orders@linprod1.publish.no.irs.gov
 - b. On the *Subject:* line, type “VITA Program Order”
 - c. Attach your saved order to this e-mail
 - d. No message text is needed
4. Next, select the “Send” button to send your order to our system

How to Place a Reorder

All orders placed after the initial order are considered reorders. Requests for products not ordered on an initial order are considered reorders.

1. Select the “Reset” button located in the top left corner of this form to clear the date needed, the last date order can be accepted, and the product quantity fields
2. Enter the date needed, the last date order can be accepted, and your reorder quantities
3. Select the “Save/ Order” button located in the top right corner of this form to save it on your computer
4. Open your e-mail account using your e-mail service provider (ex: Yahoo, MSN, Microsoft Outlook)
5. Open and create a new e-mail
 - a. On the *To:* line, type pdf.orders@linprod1.publish.no.irs.gov
 - b. On the *Subject:* line, type “VITA Program Reorder”
 - c. Attach your saved reorder to this e-mail
 - d. No message text is needed
